



REGULATION FOR THE CONCESSION OF UNGUARDED AREA GENERAL CONTRACT CONDITIONS PURSUANT TO ART. 1341 OF THE CIVIL CODE – “P3” PARKING AREA INTENDED FOR CUSTOMS CIRCUIT – Customs and Monopolies Agency – Gorizia Customs Offices

The service is offered to the public pursuant to art. 1336 of the civil code under the following conditions:

DEFINITIONS

For the purposes of this Regulation for the concession of unguarded areas, the following expressions, both in the singular and plural, shall have the meaning indicated below:

- a) “Supplier”: SDAG S.p.a. with sole shareholder, concessionary company for the parking areas of Autoporto di Gorizia and Stazione Confinaria di S.Andrea, Gorizia – Holder of the Authorization for the area intended for Customs Circuit issued by the Customs and Monopolies Agency – Gorizia Customs Office;
- b) “User”: The buyer who directly uses the service offered by the Supplier;

ART. 1. Parking is permitted in the parking areas for vehicles intended for customs control, according to the rules set out in the following general contract conditions pursuant to articles 1336 and 1341 of the Civil Code.

With the introduction of the vehicle and the collection of the entry ticket (containing the day and time of issue), a contract for the concession of an unattended area is activated between the User and the Supplier, without the obligation of surveillance and custody. The Supplier is therefore not responsible for damage and theft committed or attempted to the vehicles or their accessories or to luggage, valuables and other objects left inside the vehicle.

ART. 2. Entry to the car park takes place from the access gate that leads to the parking areas delimited by barriers, alternatively according to the following methods: a) Collecting the entry ticket from the column positioned there; b) Using the card-in system; c) reading the license plate (if the User has previously signed a contract with the Supplier)

Any consequences arising from the loss of the license plate are the responsibility of the User in accordance with the provisions of Article 8. Entry entails authorization to park according to the rates displayed at the access gate to the individual parking areas. The User is advised not to leave the ticket inside the vehicle exposed to sources of light and/or heat.

ART. 3. Users have the duty to:

- Scrupulously respect road signs and the rules of the Highway Code;
- Follow the direction of traffic indicated by the signs and maintain a speed no higher than walking pace;
- Leave the vehicle parked with the engine off and braked perfectly;
- Keep the ticket until the moment of collection of the vehicle and exit from the parking areas.

If failure to comply with these duties results in damage to third parties, the User will still be responsible for such damage.

ART. 4. Users are prohibited from:

- Parking unnecessarily with the engine running;
- Obstructing traffic by parking along the traffic lanes and in any other space outside the parking areas delimited by barriers;
- Carrying out any fuel transfer;
- Spilling oil or other material that could dirty and/or damage the pavement or drains; in the event of damage to the pavement, the repair costs will be charged to the User;
- Leaving the vehicle parked for more than 15 days, unless prior notification and authorization by the Supplier;
- Unhook and/or park trailers;
- Accessing the parking area with cars unless authorized by the Supplier.

ART. 5. Payment must be made at the appropriate cash desks before collecting the vehicle, or upon prior agreement with the Supplier. In the event of unavailability of the automatic cash desks or upon instructions from the Supplier's staff, payment must be made at the manned cash desk "INFOPOINT".

Payment for parking at the automatic pay stations can be made in cash, credit card or debit card.

ART. 6. The vehicle must exit within 20 minutes of payment. After the above-mentioned grace periods, the User will be required to present the payment ticket again and make a new payment according to the rate applied starting from the expiry of the previous one.

ART. 7. Failure to pay authorizes the Supplier to not allow the vehicle to exit. The User who shows up at the pay station without the entry ticket is required to provide documents certifying the actual ownership of the vehicle and any other document that may be useful to demonstrate the duration of the parking. In the event of failure to produce even partial documents, the User will be required to pay the sum corresponding to a continuous parking of 7 days.

ART. 8. By parking the vehicle, the User acknowledges having read and accepted, also pursuant to art. 1341 of the Civil Code, all the rules contained in this regulation, undertaking to scrupulously respect them.
